ABOUT THE BRANSON MOMCO INC

The Branson MomCo is a local chapter of The MomCo by MOPS International whose mission is to empower all women with young children by showing the unconditional love and freedom we have in Christ, sharing our stories of freedom and truth, and genuinely welcoming and accepting all moms with our words and actions. We seek to be the hands and feet of Jesus, meeting women where they are, in the midst of a challenging phase of life. We believe we are merely servants partnering with you in God's greater plan.

In 2020 Branson PM MOPS Incorporated was founded and approved as an IRS 501(c)(3) non-profit organization classified as a public charity. In early 2024 we followed The MomCo, formerly MOPS International, in a re-brand and name change, so we are now known as The Branson MomCo Incorporated. Our organization is also home to our sister ministry, The Branson MomCo Next, formerly Branson MOMSNEXT.

OUR SPECIFIC NEEDS

- **Childcare (\$)** || We provide childcare at our monthly large group meetings (every 2nd Tuesday) and our monthly leadership team meetings (every 4th Tuesday) for anywhere from 30-70 children. This is our largest expense. We need to attract excellent workers and enough workers for our large group. Currently we have excellent workers but we do not have enough. In an effort to remedy this, we are increasing our base pay from \$30/night to \$45/night. For the 2024-2025 year we have budgeted \$8,000 for Childcare.
- **Benevolence Fund (\$+)** || Our benevolence fund gives temporary help to moms in desperate situations due to illness or crisis, by paying for their rent, utilities, groceries, gas, etc. Each of our local members must also be a member of The MomCo International. This is an annual fee of \$35. Continuing this year, we plan to cover 75% of The MomCo International fee for EVERY MOM in our group to lighten their financial burden and bring more moms into our community of support. For the 2024-2025 year we have budgeted \$4,500.
- **Incorporation Expenses (\$)** || We have annual legal and accountant fees for filings and services. We also pay annually for a P.O. Box and website. For the 2024-2025 year we have budgeted \$800.
- **Hospitality (\$+)** || We desire to make every woman who walks through the doors of our meetings feel seen, loved, and accepted. We want to make our meeting space look and feel inviting, give \$5 birthday gift cards, give away small items or gift cards at each meeting, and provide each mom a treat around major holidays (i.e. Christmas, Valentine's Day, Mother's Day, etc). And traditionally we cater at least one meeting per year. We seek product donations for all we can before purchasing items/food ourselves. For the 2024-2025 year we have budgeted \$2,500.
